ORDER

Whereas M/s Nectar Life Sciences Ltd. has participated in the medicine tender No. 201101 which was opened on 6.6.2011.

Whereas M/s Nectar Life Sciences Ltd. has secured the supply order for 18 drug items against the tender No. 201101 and has started the supply of the items to the various Hospitals/Institutions/SHS/MHS and DHS central store of Delhi Govt. as per the terms and conditions of the above cited tender.

Whereas as per the standard procedure, this office vide its letter dated 05.05.2012 has sent the copies of the documents to the Drug Control Authority, Baddi, Himachal Pradesh for verification. In reply to the above said letter, this office received a verification certificate dated 27.07.2012 from Drug Control Authority, Himachal Pradesh, which was delivered by hand. On further verification through e-mail, it has been intimated by the State Drug Controller that the letter dated 27.07.2012 was not issued by their office and is fake and forged one.

Whereas a memorandum has been issued by this Office vide OM No. F1(2)/43/DHS/CPA/2011/48917-19 dated 30.08.2012 and again another show cause notice was issued by this office vide No. F1(2)/43/DHS/CPA/2011/55240 dated 26.9.2012 directing the firm to explain the reasons for submitting fake and forged documents. Though the firm has replied to the above said memorandum and show cause notice, they have not explained satisfactorily the circumstances which led to submission of fake documents.

Whereas sufficient time and opportunity has been given to the firm to explain their stand. The explanation submitted by the firm is quite unsatisfactory and unacceptable.

And, therefore, it has been decided to **black-list** the firm permanently and to debar it from participating in further procurement process.
